



# American Legion Helps With Claims

Eligibility for Combat-Related Special Compensation (CRSC) can come from injuries suffered during armed conflict or training that simulates war, while on hazardous duty, or from an instrumentality of war, such as exposure to Agent Orange or while in a combat vehicle. To be eligible for CRSC, applicants must: (1) be entitled to and/or be receiving military retired pay, (2) be rated at least 10 percent by VA, (3) waive all or a portion of their military retired pay, and (4) file a CRSC application with their respective branch of service. The American Legion can help with filing claims for CRSC through its <a href="network of department service officers">network of department service officers</a> and at no cost to the applicant. # Supreme Court strikes down Stolen Valor Act

The Supreme Court on Thursday (June 28<sup>th</sup>) rejected a 2005 federal law that punishes people who lie about medals and military service, concluding it had a sweeping and chilling effect on free speech.

The 6-3 decision in United States vs. Alvarez involves the case of a California water board member, Xavier Alvarez, who falsely claimed to have received the Medal of Honor.

He was prosecuted under the Stolen Valor Act. He pleaded guilty but reserved the right to appeal. His sentence was three years probation, a \$5,000 fine and community service.

"Though few might find (Alvarez's) statements anything but contemptible, his right to make those statements is protected by the Constitution's guarantee of freedom of speech and expression," Justice Anthony Kennedy wrote for the majority.

He wrote that the First Amendment "protects the speech we detest as well as the speech we embrace."

Proponents of the law, including the nation's largest veterans organization, the 2.4-million member American Legion, expressed dismay over the ruling. But they held out hope that a different version might survive legal review.

"We felt good about portions of the decision which suggest that a more narrowly tailored bill which incorporates traditional fraud elements would be upheld," says Fang Wong, national commander of the American Legion.

Allowing lies about medals to go unpunished "is in fact a degradation of the value and honor of those that earn the medal," says Harold Fritz, a Medal of Honor recipient and president of the Congressional Medal of Honor Society.

Kennedy said that the law as written would criminalize any false speech, even "personal, whispered conversations within a home" and this was granting the government too much power.

Fordham University Law Professor Abner Greene said the majority appeared to leave open the possibility of a law that would penalize lies about valor if they were shown to be a basis for fraud or monetary gain.

"I think that some sort of revision could be constitutional," Greene says.

Kennedy's plurality opinion was signed by Chief Justice John Roberts and Justices Ruth Bader Ginsburg and Sonia Sotomayor. A concurring judgment by Justice Stephen Breyer was joined by Justice Elena Kagan.

Justices Samuel Alito, Antonin Scalia and Clarence Thomas dissented, arguing that the law poses no threat to free speech, but rather punishes lies that if allowed to continue, are "undermining our country's system of military honors and inflicting real harm on actual medal recipients and their families."

# **Email scam targets vets, service members**

Emails are being sent to individuals – including military members, military retirees, and civilian employees – that appear to be sent by Defense Finance and Accounting Services. Although the email appears to come from DFAS and displays a .mil email address it is actually from a non-government email account.

The emails indicate that individuals who are receiving disability compensation from the Department of Veterans Affairs may be able to obtain additional funds from the IRS. These emails are not issued by DFAS.

The email indicates that individuals receiving VA disability compensation can receive additional funds from the IRS by sending copies of VA award letters, income tax returns, 1099-Rs, Retiree Account Statements and DD 214s, to a retired colonel at an address in Florida.

These schemes can be quite costly for victims. Promoters may charge exorbitant upfront fees to file these claims and are often long gone when victims discover they've been scammed.

Taxpayers should be careful of these scams because, regardless of who prepared their tax return, the taxpayer is legally responsible for the accuracy of their tax return and must repay any refunds received in error, plus any penalties and interest. They may even face criminal prosecution.

To avoid becoming ensnared in these schemes, taxpayers should beware of any of the following:

- Fictitious claims for refunds or rebates based on false statements of entitlement to tax credits.
- Emails from unfamiliar senders asking for personal information .
- Internet solicitations that direct individuals to toll-free numbers and then solicit Social Security numbers or other personal information.

If you receive a notice from the IRS, respond immediately. If you believe someone may have used your Social Security number fraudulently, please notify IRS immediately by responding to the name and number printed on the notice or letter. You will need to fill out the IRS Identity Theft Affidavit, Form 14039.
